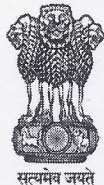

The above officials may be allowed as per this order to assume charge on promotion. The promotion will take effect from 01.01.2025 or the date on which the official assumes the charge as Upper Division Clerk on the basis of this order, whichever is later.

On promotion to the post of Upper Division Clerk, the officials will draw pay in Level - 4 of 7th CPC Pay Matrix as per the provisions of FR22(I)(a)(1) and the pay will be fixed as per Pay Rules. The Official shall exercise the option for fixation within one month from the date of promotion. The officials will draw actual pay from the date of assumption of charge to the promoted post.

Those who refuse the offer of promotion will not be considered for regular promotion for a period of one year from the date of refusal of promotion or till next vacancy arises, whichever is later, and will also be passed over resulting in loss of seniority, as per rule, and the other officials promoted on regular basis prior to the dates of their next promotion to the cadre of Upper Division Clerk will become senior to them.

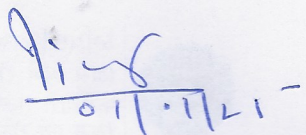
The above officials for the time being are promoted at the same place and their due transfer orders involving transfer/posting will be issued in due course.

The promotion of the above official to the post of U.D.C will be subject to completion of training for promotion to the post of U.D.C or U.D.C/C, as devised by ESIC, within one year of date of meeting of the DPC.

The above promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court as per DOPT O.M. No.F.No.36012/11/2016-Estt.(Res-I) (Pt-II) dated 15.06.2018.
