OFFICE ORDER NO. 59 OF 2026

WHEREAS, Shri Deep Raj (Shri Raj Deep) S/o Sh. Shyama Prasad the then Lower Division Clerk, Sub-Regional Office, Vadodara was terminated from the service of the ESI Corporation with effect from 22.01.2019.

WHEREAS, Shri Deep Raj (Shri Raj Deep) S/o Sh. Shyama Prasad the then Lower Division Clerk, Sub-Regional Office, Vadodara challenged the termination by filing Original Application No.157 of 2019 before the Hon'ble Central Administrative Tribunal, Patna Bench. Hon'ble CAT, Patna Bench vide its order dated 06.03.2025 in OA No 157 of 2019 had declared the termination as invalid.

WHEREAS, an appeal was filed against the aforesaid order of the Hon'ble CAT, Patna Bench, in the form of Civil Review Petition No. 19736 of 2025 before the Hon'ble High Court of Patna. The Hon'ble High Court of Patna, vide its judgment dated 16.12.2025 in Civil Review Petition No. 19736 of 2025, upheld the order of the Hon'ble CAT, Patna Bench.

WHEREAS, the Headquarters Office, vide letter No. C-22/15/29/2025-E.II dated 05.03.2026, directed compliance with the judgment dated 16.12.2025 passed by the Hon'ble High Court of Patna in Civil Review Petition No. 19736 of 2025.

NOW THEREFORE, in compliance with the judgment dated 16.12.2025 passed by the Hon'ble High Court of Patna in Civil Review Petition No. 19736 of 2025, the Competent Authority hereby **reinstates Shri Deep Raj (Shri Raj Deep), son of Shri Shyama Prasad, formerly Lower Division Clerk, to the service of the Employees' State Insurance Corporation with immediate effect.**

AND FURTHER, the said Shri Deep Raj (Shri Raj Deep) S/o Sh. Shyama Prasad, Lower Division Clerk is hereby posted to the **Legal Branch, Regional Office, Ahmedabad.** He is directed to report for duty at the aforementioned place of posting **within three days of receipt of this order.**
