The officials who are already officiating as Assistant/H.C. on 21.03.2025 will be deemed to have been promoted to the post of Assistant on regular basis on 21.03.2025 itself provided they are officiating without interruption and accept the above promotion.

The officials who are working in the cadre of UDC, are to be relieved as per this order to assume charge on promotion, their promotion will take effect from the date on which they assume charge as Assistant on the basis of this order.

On promotion to the post of Assistant, the above officials will draw pay in Level - 6 of 7th CPC Pay Matrix as per the provisions of FR22(I)(a)(1) and their pay will be fixed as per Pay Rules. The Officials shall exercise their option for fixation within one month from the date of promotion. They will draw actual pay from the date of assumption of charge to the promoted post.

If any the above officials refuse the offer of promotion, they will not be considered for regular promotion for a period of one year from the date of refusal of promotion or till next vacancy arises, whichever is later, and will also be passed over resulting in loss of seniority, as per rule, and the other officials promoted on regular basis prior to the date of their next promotion to the cadre of Assistant will become senior to them.

The above officials for the time being are promoted at the same place and transfer orders involving transfer/posting will be issued in due course.

The above promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court as per DOPT O.M. No.F.No.36012/11/2016- Estt.(Res-I) (Pt-II) dated 15.06.2018 as well as the outcome of the orders of Hon'ble CAT, Ahmedabad Bench for O.A No. 543/2024, 544/2024, 545/2024, 546/2024, 547/2024, 548/2024 & 549/2024 dated 31.12.2024.
