With reference to above subject, requests have been received from various stakeholders to provide waiver for refund of Fixed Medical Allowance received by them for joining ESIC Pensioners' Medical Scheme.

ईएसआईसी पीएमएस के 25.5.2021 के संशोधित दिशानिर्देशों के अनुसार, यदि पेंशनभोगी सेवानिवृत्ति की तारीख के बाद पीएमएस में प्रवेश के लिए अपना विकल्प प्रस्तुत करता है तो उसे 30 रुपये का प्रवेश शुल्क देना होगा एवं उसके द्वारा प्राप्त FMA को वापस करना होगा।

As per revised guidelines of ESIC PMS 25.5.2021, If the pensioner submits his option for entry to PMS after the date of retirement he would be required to pay an admission fee of Rs. 30 and refund the FMA received by him.
