#### B. Recommendation of the committee :

The committee has gone through the transfer policy dated 07.12.2022 and all the documents as provided. The committee after discussion in depth, keeping in view various aspects like in-position staff vis-a-vis sanctioned post, commissioned beds, functional requirement of staff and other parameters etc., has taken/decided following key-parameters for recommending transfer in Paramedical and Nursing cadres -

- 1. As per the transfer policy dated 07.12.2022 read along with the subsequent HQRS clarification received vide email dtd 22.09.2023 regarding tenure in context to para 4.3 and 7.3 of the transfer policy, committee has considered/counted the tenure of an employee at an ESIC Institution irrespective of the post held by an employee.
- 2. The recommendations of transfer in different hospitals of Gujarat Region are rationalised in a manner so as to maintain parity in availability of the manpower against the sanctioned strength and to fulfill functional requirement in all the hospitals in the region, since in some of the cadres there are shortage of manpower in all hospitals. Further, it is tried to maintain shortage equally among the hospitals and while recommending transfer minimum disturbance is also ensured as far as possible.
- 3. As per para 8.8 of transfer policy employees who did not give options for transfer in online Module (ERP) and have completed maximum tenure as per the provision of this policy are also considered for transfer.
- 4. As per HQRS office circular number Z-11011/6/2022-MecVI dated 09.01.2023 period of diversion has been counted at the ESIC Institution where the official has actually performed his her duties and accordingly tenure of the official as per para 4.3 of transfer policy has been counted.

#### C. <u>Cadre-wise recommendation for transfer</u>:

There are 31 Paramedical Cadres and 2 Nursing cadres in respect of transfer to be considered. Committee has considered the request in Senior Nursing Officer and Nursing Officer cadre and accordingly recommendation of the committee in respect of the Senior Nursing Officer and Nursing Officer Cadre are enclosed with this report for kind consideration of the Competent Authority-
