Subject :- Appointment / Renewal of Private Registered Medical Practitioners as Authorized Medical Attendants (AMAs) under CS (MA) Rules, 1944 for the year 2025-2026-reg.

In terms of CS(MA) Rules, the following Private Registered Medical Practitioners are appointed as AMAs for ESIC staff / Pensioners and their family members under jurisdiction of RO-Ahmedabad for the period from 23.06.2025 to 22.06.2026 mentioned below.

Terms and conditions:

- 1) The appointment of AMAs is valid for one year and automatically stands expired on 22.06.2026. It can, however, be renewed on fresh application by Doctors in the respective months.
- 2) The AMAs are requested to send their renewal letter for the next term at least 2 months before expiry of the present term for renewal.
- 3) The treatment at the consulting room of AMA is limited to 10 days with maximum of four consultation and normally ten injections. The number of injection may go up to 15 depending on patient's ailment.
- 4) The limit of 10 day's treatment at consulting room of AMA may be increased to 40 days. The total number consultations will, however, remain 04 at an interval of 10 days.
- 5) The AMAs are further requested to follow the rules and orders strictly issued under CS (MA) Rules.
- 6) ESIC RO- Ahmedabad reserves the Right to terminate the appointment

if services of AMA are no longer required.
